



Privacy Policy

Your continued use of our website & services constitutes agreement to be bound by the following terms.

General

This Privacy Policy applies to all personal information collected by Now Legal via this web site and forms part of the Terms of Use of the web site. We will only collect and use personal information as set out below. If you have questions or concerns regarding this Privacy Policy, please contact us by one of the methods listed on this web site.

Collecting Personal Information

Now Legal will not collect or monitor any personal information about an individual without their consent. The only personal information we collect is what you provide voluntarily.

Personal Information

If you input personal information into our web site we will collect that personal information. We collect personal information to provide you with the service you request and to allow us to maintain proper business records. Some provision of personal information is optional. Tracking Technologies

We may disclose personal information to our service providers who assist us in operating the web site and providing services to you. This includes (but is not limited to) third parties such as barristers. We will only disclose personal information to an unrelated third party with your consent. Now

Legal may, at its discretion, use third parties to provide essential services on our web site or for our business processes. We may share your details as necessary for the third party to provide that service. These third parties are prohibited from using your personal information for any other purpose. Now Legal does not share any information with third parties for any unknown or unrelated uses. We reserve the right to disclose your personal information as required by law and when we believe that disclosure is reasonably necessary to protect our rights and/or comply with a judicial proceeding, court order, or legal process served on our web site.

We may use personal information for communications to customers and other third parties as is reasonably necessary to provide our services, such as emails, accounts information, critical service details and relevant information. We will not use your personal information for indiscriminate promotional purposes. We will only send promotional material to you if you consent to receive such material. You will be notified when your personal information is collected by any third party that is not our agent/service provider, so you can make an informed choice as to whether or not to share your information with that party.
